Media

Paintings, sculpture, hand-pulled artist's prints (e.g., etchings), drawings, mixed media, ceramics, photography and jewelry. Jewelry consisting primarily of purchased elements will not be accepted.

NOTE: Artists may exhibit only their own work. Any copies or reproductions of the artist's work must be labeled as such.

All work displayed must be original art. Giclee prints may only be displayed in bins.

Jurying

First time applicants, previous exhibitors who plan to exhibit a different medium, and ALL JEWELERS are required to be juried into the 2019 fair.

All artists will be required to re-jury every 3 years.

2019 = Jewelers

2020 = Photographers/print makers/all 2D art

2021 = Ceramics/sculpture/all 3D art

Deadline

All applications, entry fees, flash drives with SASE must be received by: **May 15, 2019.**

Completed applications should be submitted with:

- Separate checks for application and jury fees.
- A flash drive or email with at least five (5) digital images for the jury committee (no photographs). Non-jurying artists should send 2-3 images for promotional purposes.
- Images can be emailed to: glenviewartleague@att.net. Be sure that your email does not reduce the size of your image, which will change the quality.

Judging & Awards

Judging begins at 11:00 a.m. on Saturday, with ribbons being awarded after the judges have completed their work. Cash awards will be presented at the end of the Fair on Sunday. Recipients must be present to receive the award.

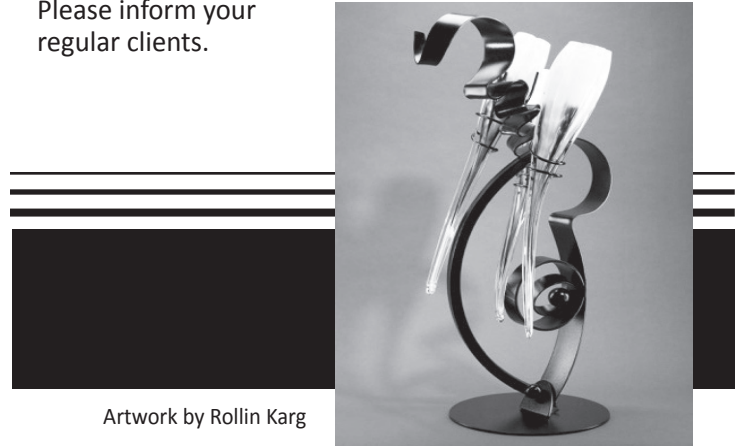
At the discretion of the judges, one **Best of Show** and several **Awards of Excellence** and **Merit** will be given.

Space

All artists are responsible for setting up and caring for their work in their allotted space. Each space is approximately 12' x 12'. Artists' tents **must be staked** into the ground. While some security is provided, artists leave their work overnight at their own risk.

Other Information

- Each accepted application is a commitment to show. No refunds will be granted after July 1st.
- No admission is charged to the public.
- Accepted artists must be present and exhibit for the duration of the Fair on both days.
- There is a Glenview ordinance that prohibits animals/pets at the fair. Please inform your regular clients.
