We welcome your application to exhibit in the Glenview Art League’s Summer Art Fair. Our new location for 2022 (2500 Chestnut in the parking lot of Attea School) has pavement for easy load in, and plenty of parking. Still in the northern suburbs of Chicago, this volunteer-run event is a beloved community tradition dating back to the 1950s. Crowds are drawn in by fine artwork and fine craft, as well as social and traditional media promotion and live music.

ACCEPTED MEDIA

Accepted media include: paintings, sculpture, prints, drawings, mixed media, wood work, fiber, ceramics, photography, and jewelry. *Jewelry consisting primarily of purchased elements will not be accepted.*

Artists may exhibit only their own work. Copies or reproductions of the artist’s work must be labeled as such. All work displayed must be original art. Giclee prints may only be displayed in bins.

FEES AND JURYING

Non-members \$220

Glenview Art League members
on record as of January 1, 2022 \$150

All artists are required to re-jury every 3 years:

- 2022 - Ceramics/sculpture/3D art
- 2023 - Jewelry
- 2024 - Photographers/print makers/2D art

First time applicants, previous exhibitors who plan to exhibit a different medium, and ALL ceramics/sculpture and 3D art are required to be juried into the 2022 fair.

APPLICATION DEADLINE

All applications, entry fees, and images must be received by: June 10, 2022.

Completed applications should be submitted with:

- Separate checks for application and jury fees.
- Email images (at least 1200 by 1200 pixels) to glenview-artleague@att.net.
 - Jurying artists: at least 5 images.
 - Non-jurying artists: 2-3 images for promotional purposes.

JUDGING AND AWARDS

Judging begins at 11 a.m. on Sat., with ribbons awarded after judges complete their work. Cash awards will be presented at the end of the Fair on Sunday. Recipients must be present to receive awards. At judges’ discretion, one Best of Show and several Awards of Excellence and Merit will be given.

BOOTH SPACE

All artists are responsible for setting up and caring for their work in their allotted space. Each space is approximately 12’ by 12’. Artists’ tents must be staked into the ground. While some security is provided, artists leave their work overnight at their own risk.

EVENT INFORMATION

- Each accepted application is a commitment to show. No refunds granted after July 1, 2022.
- No admission charged to the public.
- Accepted artists must be present and exhibit for the duration of the Fair on both days.
- A Glenview ordinance prohibits animals/pets at the fair. Please inform your regular clients.

As part of the fair, the Glenview Art League holds a Silent Auction to raise funds for our Youth Art Fair and Scholarship Program. Please consider a donation to the Silent Auction, which is tax deductible in accordance with the law.
