1-person show with space for about 7-9 pieces of varying size

___ **Colonial Dental (6 months)**

3 medium pieces in dental exam rooms with blue walls (1 vertical piece with a companion horizontal piece). Bring a variety, office managers help select the pieces to show.

___ **Northbrook Court (6 months)**

Various large and medium spaces, room for 5-6 artists, 10-18 feet of wall space per artist. Easels or other display material may be required.

___ **Oil Lamp Theater (terms coordinated with performances)**

Space for 1 artist, approximately 8-10 medium to large pieces.

___ **Tarantur & Associates**

Space for 1 artist, approximately 8-10 medium and large pieces.

NOTE: The Exhibit Committee reserves the right to decline work deemed unacceptable and/or replace artists unable to meet pre-set dates/times.

One person exhibit in two rooms. One room requires a vertical piece 12-15" wide and a companion horizontal piece. The other room requires 1 medium size piece. Artist should bring extra - the office manager chooses the pieces to hang. The rooms are exam rooms, so work should be soft colors, soothing images. Walls are blue.
